

Rental Agreement

Please review the following terms and agreements pertaining to your Rental:

Rental of Limousine and or the other vehicles from Star Party Bus is subject to the following terms and conditions:

Unless otherwise specified, all reservations require a major credit card.

Reservations are finalized upon receipt of a signed contract/agreement.

There is a 2(Two) hour minimum for the use of a Party Bus from Sunday thru Thursday.

There is a 3 (Three) hour minimum for a Party Bus during the evenings on Fridays and Saturdays.

No possession, sale or consumption of any type of narcotics or illegal drugs is permitted. Violations will result in immediate termination of contract and services and forfeiture of all paid deposits and fees for service.

Client and renter are responsible for his/her guests, for any damage to the interior and equipment of the vehicle. **This is including but not limited to: gum, wine and alcohol spillage, vomiting, breakage of champagne, wine and drink glasses, breakage of decanters, breakage of lights, television, VCR, radio, CD player. Repair and replacement of items shall have a minimum charge of at least \$100.00 (one hundred dollars). All passengers agree to behave in an orderly and well-behaved manner. STAR Party Bus reserves the right to expel any person form the vehicle and/or terminate this contract in the event of a violation of any of these conditions by any passenger. In event of such early termination, no portion of the rental fees shall be refunded.**

While we are happy to let you bring various personal items, we do not take any responsibility for items that are left in the vehicle during or after completion of the limousine rental period.

STAR Party Bus shall not be held responsible for late arrival caused by (but not limited to) acts of nature, traffic delays, breakdown, incorrect pickup and drop-off information, and any situation beyond our control.

If the limousine rental is for a minor under the age of 18 (eighteen) this agreement must be signed by either a **parent or legal guardian over the age of 18.**

All vehicles are quoted subject to availability at the time of booking. A deposit of 50% of the total amount is required at the time of booking and is nonrefundable. The balance is due at the time of service.
